Golf Course Report (Paul)

Waiting on the grass to start growing, need rain for that to really get going

Top-dressed around the greens

Aerification of the greens has started, need air to the roots for better growth

Come July will aerate with larger holes and top dress with sand

Irrigation system continues to be a challenge

Even after slicing the fairways, they're still too compacted

Please use 90 degrees rule for golf course

Also need to partner up with 2 golfers per cart

Transitioning from over-seeding from last fall, again need rain to speed this up

When you see the guys working on the course, please yell "Fore" to get their attention

This lets the golf course staff know you're there and are waiting to proceed

Commended the members for not leaving trash around the golf course

No cigarette butts, No broken tees

Rules & Regulations Discussion (Wayne & all attendees)

Elaboration about the 2 golfers per cart rule

Have posted signs to make everyone aware of the rules & regulations

Need to pay attention and follow all the rules & regulations

There is a rule about golf carts being parked around the tree outside the lobby

Need to have golf clubs on the cart, otherwise don't park there

If you're joining someone on their cart, please park your cart in the east parking area All members need to follow the Rules & Regulations

Treasurer's Report (Wayne as Sally is on vacation)

Total April Income: \$48,365.95 YTD: \$219,053.94 Total April Expenses: \$35,086.02 YTD: \$161,549.31 Net April Income: \$13,279.93 YTD: \$57,504.63

Kitchen made money in April, Bar's going great, Pro Shop also made money

Main Account: \$250,598.07 Capital Improvement: \$149,691.25 Cart Path Fund: \$17,621.86

Electronic Fund Transfer: \$5,000 Petty Cash: \$600

Expenditures Report (Wayne)

New flooring has been completed in the Par-Tee room

Will be purchasing two mats to protect the new floor for the dart board areas

The used fairway mower has been purchased, approximately \$7,900

Question about Cart Path Fund – when do we have more work done

We're waiting until the funding reaches about \$30,000

Contractor needs a sufficient amount of work before they're willing to start

Need to consider replacing the carpet in the Café area (\$6,000 just for materials)

Will be sent to the proper committee for investigation, discussion & solution/proposal

Clubhouse Report (RoseAnn)

Awesome Mother's Day Buffet (77 participants)

Will be doing similar for Father's Day Buffet

Other events coming include Memorial Day, Wedding, and July 4th

These events help us make a profit

Maintenance needed on Freezer and Oven

Still doing additional activities on Tuesday (putting, darts, etc.)

Friday's have been slow over lunch

It is not worth paying a cook if not enough are ordering/eating

Looking at items the bartender/waitress can prepare & deliver

First Friday Night dinner went well (over 20 participants)

Will review if we should put sign out front of the lobby/clubhouse for notification

Friday Dinners are open to all High Point residents (Eat-In, Take-Out & Delivery)

Secretary's & VP's Report (Dale)

April member meeting minutes

Have been posted on the Bulletin Board in the Clubhouse

Motion made by Tom A to approve, 2nd by Tom L – passed unanimously

Membership Report (Linda)

Total of 339 members compared to 365 at the end of 2022

Financially we're ahead of 2022 in terms of income from membership fees

105 Green Fees packages sold so far in 2023 (over \$30,000 income)

Social Membership – special Summer Social Membership for \$10 covers June thru August 2024 Social Memberships go on sale September 1, 2023 (\$50) covers Sept 2023 thru 2024 Question on "50/50" versus "Sharing the Wealth" payout

Split prize into multiple winners, might depend on amount available

Board needs to discuss and will share with membership

Looking for more volunteers to sell the "50/50" tickets, will be posting this request

Comments & discussion on membership and attendance at the meetings and other events

Late Spring thru Summer are tough times in terms of participation

Membership committee continues to work on recruitment ideas

We are limited on income sources as a not-for-profit (most must be from members)

We do have a few sponsored memberships for non-HP residents

Working on how to survey HP Residents about why they don't play golf here

Animosity between community and golf course – why and what drives this?

Need to investigate and come up with ways to improve the relationship

We are opening more and more events to all HP residents (dinners, etc.)

Rule – can't retrieve balls from posted properties, unless granted permission

Golf Members need to "take the high road" in every instance

Caught up on list of issues

Golf & Publicity Report (Jim)

Next tournament will be the Memorial Day Scramble from the Gold Tees
